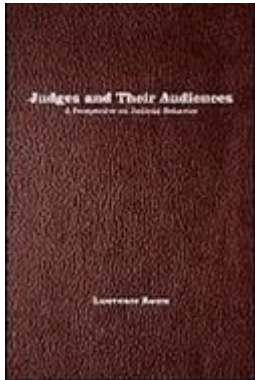

Ross explores damages and remedies at various levels as he covers a wide range of topics including compensatory damages, injunctive relief, punitive damages, remedies that are available for patent owners, attorney fees, and court costs. Other important topics include a discussion of infringement that occurs online and ex parte seizures.
