We were saddened to learn of the death on June 7 of John Rankine, a longtime IBM executive and USCIB member who served as vice chairman of the Business and Industry Advisory Committee to the OECD in the late 1970s. He was 77.



"John was a longtime participant in USCIB's telecommunications and information technology activities," recalled USCIB President **Peter M. Robinson**. "He was one of the most-recognized names in the field, and he helped us lead the way in promoting greater standardization internationally and in educating governmental decision-makers about newly-developing technologies."

Mr. Rankine he grew up in Scotland and earned engineering degrees from the University of Glasgow, later completing post-graduate studies in atomic physics at McGill University in Montreal. After a stint in Brazil with American and Foreign Power, he joined IBM, advancing through executive positions in
